My primogeniture in the Royal house of the Bourbon-Two Sicilies and the rights derived from it are not questionable.

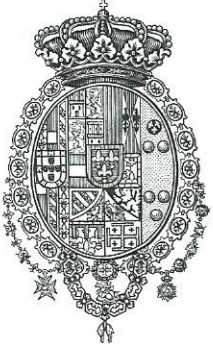

Since then, and I would add, from that very moment specifically, some people close to you have been trying, by all means, to create discord again, with attacks that, regretfully, haven't stopped to this day, through internet, by e-mail, conferences, and the press in general, trying to revile my family in a useless attempt to alter history, creating disagreements between us.

It is not my style to respond to these attacks, nor to enter in useless disputes that would only contribute to the discredit and loss of prestige of our family and our beloved Constantinian Order. My Council, my family and I have continued in this line, not answering any of these grievances.

However, the unilateral decision you have made this last 12<sup>th</sup> of May, completely unjustified in its form, without consulting me or a big part of our family, and without the authority to do so, made it necessary for me to give a resounding and unavoidable response.

In spite of all this, and this is the precise reason of my letter, I am still open to reconciliation once again. I don't want to go back to the past, or waste my time in discussions. I was and still am, open to dialogue, as I have always wished for peace and harmony within our family.

I want to dedicate my life to the strengthening of our beloved Constantinian Order, with the purpose of achieving its praiseworthy objectives of helping the Church and those in need, and also to my family and my work.

We have just participated in the pilgrimage of this jubilee year of mercy, living moments that call for interior peace and reconciliation with God and every man. My conscience is calm and so I wish it for those around me.

I deeply regret this situation. With the same strength I wish for peace and harmony within our family and, as legitimate heir, I ratify firmly my rights.
